GROUP HOMES: THE ORGANIZATION OPERATES FIVE GROUP HOMES THAT ARE CERTIFIED AS QUALIFIED RESIDENTIAL TREATMENT PROGRAMS (QRTP); POSITIVE ALTERNATIVES-AMERY, POSITIVE ALTERNATIVES-MENOMONIE, POSITIVE ALTERNATIVES-RIVER FALLS, POSITIVE ALTERNATIVES-WISCONSIN RAPIDS, AND POSITIVE ALTERNATIVES-MARATHON COUNTY ARE EACH LICENSED BY THE WISCONSIN DEPARTMENT OF CHILDREN AND FAMILIES UNDER WISCONSIN ADMINISTRATIVE CODE DCF 57. THE HOMES PROVIDE STRUCTURE, SAFETY, AND ACCOUNTABILITY TO YOUTH IN NEED OF ALTERNATE CARE.
